Duties of Wardens and PCC Members

Extract from Canons of the Province of South East Asia, Section E, 1.2:

Church wardens are to 'be foremost in representing the laity and in cooperating with the incumbent (Vicar); they shall use their best endeavours by example and precepts to encourage the parishioners in the practice of true religion and to promote unity and peace among them. They shall also maintain order and decency in the church, especially during the time of divine service."

Extract from Constitution of the Church of the Ascension, Section 2.4.1 and 4.4:

- 2.4.1 the nominee shall be a person recognized as fulfilling the qualifications as taught in the Word of God, especially in 1 Timothy 3, Titus 1:5-9 and Acts 6:3
- 4.4 The PCC shall assist the Vicar in the initiation, conduct and development of the affairs of the Church of the Ascension and in particular be responsible for:
- 4.4.1 the conduct of the financial affairs of the parish and maintenance of proper accounts;
- 4.4.2 the care, maintenance and preservation of the fabric, good and ornaments of the Parish;
- 4.4.3 the preparation of an annual report on the Parish, including its financial affairs and annual budget;
- 4.4.4 the appointment, terms of service and dismissal of lay staff, other than those appointed by the Bishop, for the public worship, maintenance and administration of the Parish;
- 4.4.5 the appointment of individuals and committees to help fulfil its responsibilities.
